CONDITIONS OF SALES

1. You are advised to inspect the vehicles before making your offer. The vehicles may be inspected between 09.00 hrs to 15.00 hrs by contacting the Transport Section on 206 0560.
2. Tenders in sealed envelopes, clearly marked “**Sale of Vehicles – Reference 02/2017**” on the top left hand corner addressed to the Procurement and Supply Officer, should be deposited in the Tender Box located at the Reception Counter of the Mauritius Oceanography Institute, Avenue des Anchois, Morcellement de Chazal, Albion, not later than Monday 15th January 2018 by 15 00 hours.
3. Tenders shall be valid for a period of 120 days from the closing date.
4. Payment of the purchase price must be effected by Cash or Bank Office Cheque in toto together with the 15% VAT to the MOI within 15 days from the date of the award of offer.
5. The deed of sale will be drawn strictly in the name of the person / company to whom the tender has been awarded. The original Identity Card (or Certificate of Incorporation in case of company including BRN) must be produced upon the award of the offer.
6. The successful buyer must take possession of the vehicle at his own cost within 15 days from the award. The vehicle will only be delivered if prior payment of the offered amount in cash / Bank Office cheque has been effected.
7. The MOI does not accept liability for any fitting, accessory or spare part which may be damaged or missing on or in the vehicle.
8. The MOI neither binds itself to accept any tender, nor will it assign any reason for the rejection of same.
